And how does this apply to sustainability?


#### BACKGROUND

- Designed for optimal efficiency,

- Modeled after galley kitchens seen in train cars


Material and color are stark, modern, and purely functional.





The kitchen was modeled after Grete Schütte-Lihotzsky's Frankfurt Kitchen.


Ceiling heights and proportions in bedrooms were specifically chosen to accommodate heights and perspectives of female occupants.
